Why MAFM VN30 ETF

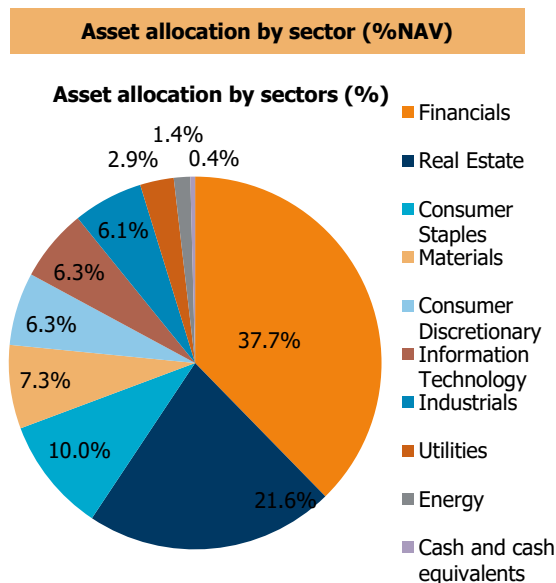
- High growth potential: The fund enables investors to access high growth potential through companies critical to the development of Vietnam economy.

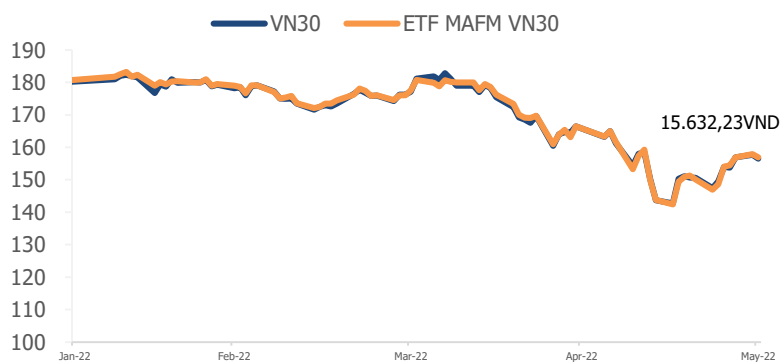
